Invitation for Bids for the Construction of 15-Bed Basic Hospital

1. The Nalgad Municipality towards the cost of **15-Bed Basic Hospital** and intends to apply part of the funds to cover eligible payments under the Contract for NM/JKT/WORKS/NCB/08/2077/078. Bidding is open to all eligible Nepalese Bidders.
2. The Nalgad Municipality invites electronic bids from eligible bidders for the construction of **15-Bed Basic Hospital** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 14,15,50,000.00
- Minimum Work experience of similar size and nature: **As per mentioned in Bidding Documents.**

3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Nalgad Municipality Dalli, jajarkot or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
4. Bidder who chooses to submit their bid electronically may download the bidding documents from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document non-refundable fee NRs.10,000 (Ten Thousand Only) in the Project's Rajaswa (revenue) account as specified below.

5. Pre-bid meeting shall be held at 10:00 AM on 08/07/2021 in **Nalgad Municipality Dalli, jajarkot.**
6. Electronic bids must be submitted to the Nalgad Municipality Office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Noon on 18/07/2021**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM on 18/07/2021 at the office of Nalgad Municipality.**
8. Bids must be valid for a period of 90 Days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 48, 50,000/- (**Fourty Eight lakh fifty thousand only**), which shall be valid for 30 days beyond the validity period of 120 Days.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Matters not covered by this notice shall be in accordance with Public Procurement Act-2063 and Public Procurement Regulations-2064.
